There are several licensable modules under the “HealthShare” name, “Information Exchange” (renamed Unified Care Record as of the 2019.1 release) is the core component of the Modular EHR, HealthShare.

Use of HealthShare to satisfy any Meaningful Use criteria requires licensing of HealthShare Information Exchange.

Specifically, dev key MCZ121 (known as either a ad-hoc or service pack) is required for to satisfy the following criteria:

- Transmission to public health agencies – syndromic surveillance – 170.315(f)(2)

### Requires Health Insight

There are several licensable modules under the “HealthShare” name, “Health Insight” is an add-on product for HealthShare Information Exchange.

Use of HealthShare to satisfy any Meaningful Use criteria requires licensing of HealthShare Health Insight in order to satisfy the 170.315(g)(1) criteria **except** for the following criteria:

- Patient Specific Education Resources - §170.315(a)(13)
- View, Download, and Transmit to 3<sup>rd</sup> party - §170.315(e)(1)
- Secure Messaging - §170.315(e)(2)

### Requires Personal Community

There are several licensable modules under the “HealthShare” name, “Personal Community” is an optional component of the Modular EHR, HealthShare.

This certified product-version requires licensing of HealthShare Personal Community to satisfy the criteria listed below:

- Patient Specific Education Resources - §170.315(a)(13)
- View, Download, and Transmit to 3<sup>rd</sup> party - §170.315(e)(1)
- Secure Messaging - §170.315(e)(2)
- Patient Health Information Capture - §170.315(e)(3)

This certified product-version requires licensing of HealthShare Personal Community to satisfy the Automated Numerator Recording (§170.315(g)(1)) for the criteria listed above.

### Requires Master Patient Index

A Master Patient Index is a solution which correlates patient identities from multiple sources.

Use of any HealthShare product to meet any Meaningful Use criteria requires licensing of HealthShare Patient Index or a 3<sup>rd</sup> party Master Patient Index product.

There are several licensable modules under the “HealthShare” name, “Patient Index” is an optional component of the Modular EHR, HealthShare.

### Requires HISP

A HISP is a server or service that brokers the transmission and receipt of messages using the Direct transport.

This certified product-version does not include HISP services. Implementation of a HISP or ongoing costs for 3<sup>rd</sup> party provided HISP services are required to satisfy the following criteria:

- View, Download, and Transmit to 3<sup>rd</sup> party - §170.315(e)(1)
- Transitions of Care - §170.315(b)(1)

### Numerator Reconciliation
